Have changes been made to the course since the last time it was taught? If so, please elaborate?

The number of topics covered by the course was reduced in order to give the students better opportunities to acquire more detailed knowledge and better understanding of the topics. Of this reason, the name of the course was changed to "JUS2321 Introduction to Chinese Civil and Commercial Law".

Course structure

The course has a balanced teaching composition with general knowledge of Chinese law, the specific information of civil and commercial law, as well as basic introduction of legal practice.

The course programme is suitable based on the description of the learning outcome. In the teaching, legal cases were given to the students in order to help them to understand the law better.

Digital elements of course completion

4 online discussion courses led by Chinese PhD students were offered in order to enhance the understanding of the course content.

Literature

It has been quite challenging to find sufficient material for the course. This is partly caused by the fact that most of the literature is published in Chinese. And since considerable parts of the legislation is fairly new, there isn't yet much academic analysis conducted in several of the areas covered by the course. We are continuously considering to the supplement and/or to make changes in the list of required/recommended literature.

How do you assess the students' workload in your course?

The students' workload was modest and most of the students can catch up with the course.

Lectures

The students had better understanding, as well as the latest development of Chinese civil and commercial law not only in theory, but also in practice.

No recording was made during the lectures.

The students were very active in the course. They asked questions and were eager to answer the questions from the lecturer.

In order to help the students to understand the lectures, the PPT slides were published online. The feedback was very positive.

Group meetings

The students were expected to give their analysis of the cases under discussion, and it worked very well.

The students were active with good preparation in the group meetings.
